Our purchasing specification for individual ingredients states that these are to comply with all relevant EU regulations in relation to food supplements, which includes the Commission Regulation (EU) 2015/1933 on polycyclic aromatic hydrocarbons (PAH), heavy metals and microbial limits, and that the ingredients are to be Non-GM and Non-Irradiated. Supplier's statements, risk assessments and Certificates of Analysis are checked and kept on file, Living Planet Ltd. also does their own due diligence tests on raw materials to assure quality and compliance to EU regulations.

Based on the above we confirm that this product is per current EU regulations on microbial levels, heavy metals and PAHs for food supplements.

The manufacturing facilities (production and clean rooms) at Living Planet Ltd. are organically certified and registered as a food business (for the manufacture of food). The premises are audited by local enforcement and authorising authorities and audited annually by the Soil Association.
